To launch the competitive entrance examination for admission into the 3<sup>rd</sup> year (Bachelor of Technology) at the University Institute of Technology (UIT) of the University of Douala, at Higher Institute of Emergence (HIE) of Yaounde and Higher Institute of Science, Technology and Innovation (HISTI) of Yaounde, at Higher Institute of Banka-Bafang (HIB-B) of Bafang, Higher Institute of Technology Advanced (HITA) of Douala, at Higher Institute of Technology Management Advanced (HITMA) of Douala, at Higher Institute the Pearl (HIP) of Douala, University Institute of Major Tropics schools (UITS) of Douala and University Institute Siantou (UIS), for the 2024/2025 academic year.

### DECIDES THE FOLLOWING :

**Article 1 :** A competitive entrance examination for the admission into the third year of Technology Bachelor of the University Institute of Technology of the University of Douala, at Higher Institute of Emergence (HIE) of Yaounde, Higher Institute of Science, Technology and Innovation (HISTI) of Yaounde, at Higher Institute of Banka-Bafang (HIB-B) of Bafang, Higher Institute of Technology Advanced (HITA) of Douala, at Higher Institute of Technology Management Advanced (HITMA) of Douala, at Higher Institute the Pearl (HIP) of Douala, University Institute of Major Tropics schools (UITS) of Douala and University Institute Siantou (UIS), for the 2024/2025 academic year.

The written examination will take place on 1<sup>st</sup> October 2024 in Douala, Yaounde and Bafang centers. The distribution of seats is as follows :

- GUSD (equivalent of L2 academic) with profile in accordance with the requested option
- Faculty Bachelor with profile in accordance with the requested option

**Article 4:** The complete application file must comprise the following documents:

- 1- A registration form to be duly **completed online** in the Web site of UIT of Douala: [www.iut-douala.cm](http://www.iut-douala.cm), printed and signed by the candidate, and stamped at CFAF 1,500 FCFA. An amount of CFAF **25,000 of examination fees** must be paid before registering online ;
- 2- A certified true copy of the required diploma ;
- 3- The transcripts corresponding to the two years preparatory to the diploma;
- 4- A certified **true photocopy** of the birth certificate issued within the last three (03) months ;
- 5- A curriculum vitae;
- 6- A labour certificate (Desirable);
- 7- Two (02) recent passport-size photographs of the candidate;
- 8- A **21 x 29.7 size** self-addressed envelope bearing a CFAF 400 postal stamp;
- 9- A simple photocopy of the National Identity Card;
- 10- A **twenty five thousand (25 000) CFA francs** banking receipt representing the examination fees to be paid at the **UBA account n° 10033 05214 14004000006 – 90, or at the BICEC account n° 01253101002-18 for admission at the UIT of Douala**;
- 11- A medical certificate issued within the last three (03) months by a state medical practitioner and testifying that the candidate is fit for higher education ;

**Article 5:** The complete files must be submitted on **25<sup>th</sup> September 2024 latest** in the Admissions Office of the Douala University Institute of Technology (UIT), Higher Institute of Emergence (HIE) of Yaounde, Higher Institute of Science, Technology and Innovation (HISTI) of Yaounde, Higher Institute of Banka-Bafang (HIB-B) of Bafang, Higher Institute of Technology Advanced (HITA) of Douala, at Higher Institute of Technology Management Advanced (HITMA) of Douala, at Higher Institute the Pearl (HIP) of Douala, University Institute of Major Tropics schools (UITS) of Douala and University Institute Siantou (UIS).

**Article 6 :** The examination has a written paper which depends on the option.

**Article 7 :** A press release from the Rector of the University of Douala will specify as necessary the planning of the various papers.

**Article 8 :** Successful candidates shall report to UIT for registration formalities within fifteen days following the date of publication of the final results. Candidates, who fail to comply with this requirement, as need arise, shall be replaced by those on the waiting list following the order of merit, through a press release published by the Minister of Higher Education on the recommendation of the Rector of the University of Douala.

**Article 9:** The Rector of the University of Douala, the Director of University Accreditations and Quality, and the Director of UIT of Douala, each in his own sphere, are responsible for the implementation of the present decision which shall be registered and published in English and in French wherever necessary./-
